Procedures for Addressing the Board

New Business

Fence damage from ice storm

The fence on O'Neal Rd near Katharina Court (by Karen Rice's home) was damaged by a delivery truck. An investigation is underway to locate the renter of the Enterprise truck. 8 slats need to be repaired. We will proceed with the repair by soliciting quotes and utilizing the contractor with the most competitive price and expedience. Hopefully, the investigation will result in reimbursement to SEA by the offender.

Storm Complaints

Complaints about the condition of the roads were discussed. Ultimately, the roads are maintained by the State and the SEA has no authority or responsibility. The board was also made aware of members' complaints to the DOT relative to scraping and salting the streets well after the snow had melted, essentially contributing to the already crumbling asphalt. Homeowners are encouraged to individually call the State DOT to request repairs or new paving!

Springdale Lake Dam

The question about the responsibility of the DAM maintenance/issues was brought to the attention of Jim Brennan. A local engineer has been corresponding and brought up issues of concern relative to the actual ownership of the dam and the responsibility of the SEA. It was decided that we would invite this firm to present to the board (30 minutes max) at our next meeting so that we can gather as much information possible before taking any actions, or, none at all.
