SPRING CLEANING

Many thanks to the small group of devoted neighbors who volunteered to help with the neighborhood Spring Cleaning. We hope you have noticed that many street signs have been straightened and the old concrete street posts have been painted. Every little bit helps!

8619 ONeal Road

I am sure that you have also noticed that the home construction at 8619 ONeal Rd. has stopped. There was a snag concerning the Raleigh Tree Ordinance which has held up permitting. The Board has been working with the owners and, hopefully, the builder will be back on the job soon.

I called the city to see about removal and was informed that it had to be by the street to be picked up. I located the deer, hoisted it into my wheelbarrow and hauled it to the street – I only tipped it over 3 times. I ultimately got it to the street and called the city again for an expedited pickup. Later that day, our Facebook page lit up with folks concerned about speeding on Lakewood which caused the deer's demise. Not so. It was me! Too funny!

Adult Social



We had planned to have an adult social in June, but the widening of Leesville Rd., the re-zoning issue, and other concerns prevented us from pulling this together. We now plan to do this on October 5th. We plan to have the fishing rodeo for the kids in the AM and the social Adult Social in the PM. There WILL be adult beverages other than Ensure! LEESVILLE WIDENING

Without notification to us, Raleigh City Council approved a plan for the Leesville Road widening. I must say that our attendance at the May 2nd DID have a positive impact. The new plan calls for a 2-Lane divided (median, side walks and bike lane) from the South ONeal entrance to Fairbanks – then a 4 lane divided road from Fairbanks to Westgate. I have attached the meeting minutes as well as a road cross-section.

Leesville Road Safe Routes to School project

This is another city/State project that is entirely separate from the Leesville widening project. You will begin to see activity at the South ONeal entrance soon. There will be a new sidewalk extending down from Shadow Wood to Leesville. This sidewalk will include handicapped accessibility. Work will be done around our monuments, but they will not be destroyed. I have met with the city planner to confirm their activities. The SEA and the homeowner are being compensated for the disruption and for replacing shrubs or flowers.
