ANNUAL MEETING

We had a most productive quarterly board meeting last week. Here are the topics we discussed and resulting decisions:

FLORENCE EMERGENCY PLAN

Our storm emergency plan proved to be quite successful. We had a tree fall across Sawyer and within an hour we had multiple volunteers on site to clear the way. We also had requests to check on senior neighbors and to check properties where the homeowner was away. Thanks so much to everyone who volunteered. This is the ultimate example of the kindness and unselfish actions of our neighbors. Again, thank you!

DIRECTORIES

The directories are out. Thanks to all those volunteers that helped with the distribution.

Unfortunately, there was a glitch transferring the data from past years. Some folks were "designated" non-members and vice versa. We truly apologize for the mistakes. Our plan of action includes:

- Reprinting the directories sometime next year.
- Having several pairs of eyes to help with accuracy.
- Giving everyone the opportunity to update their personal info (family members/pets' names, etc.).
- NO LONGER "bolding" names to reflect paid memberships we will put together a new strategy to convince non-members to join our association.

• Considering advertisements on the back cover (which is now blank) to offset expenses. We are thinking of business card size ads. We will ask members/neighbors first before we approach other possible supporters. The price will most likely be a little less for homeowners.

Last week we had an arborist visit to evaluate the current situation. The trees are in serious need of pruning and the arborist, in conjunction with our Garden Club, will be making recommendations.
